APPLICATION

KMA is a dry powder that is added directly to the concrete/mortar during mixing. Add KMA to concrete/mortar and mix to desired consistency. Most mixes will require less water than usual. Mix for at least 5 minutes after adding to the mixer. Install cement mortar/screed/concrete as per IS guidelines. The dry application ensures that your w/c ratio in concrete is maintained, and the durability and strength gain are as designed.

CURING

Protect from rain until hardened. Protect from hot sun or wind for at least 24 hours. Cure the concrete/mortar application by misting with water repeatedly for 2 or more days.

DOSAGE

- Dosage is 0.8% of cement content.
- As per the site requirements, the dosage may be increased maximum upto 1kg/bag in consultation with KRYTON representative. (Cement as per IS 456:2000)

SAFETY

For professional use only. Avoid contact with skin or eyes. Avoid breathing dust. Wear long sleeves, safety goggles and impervious gloves. The safety precautions for KMA treated mortar are the same as for regular mortar.

PACKAGING

KMA is available in 20 kg bags.
